#### **Savings Transfer Overdraft Protection**

We want to inform you about an important update to your Member Agreement regarding the Savings Transfer Overdraft Protection feature.

#### What's Changing?

Automatic Transfers: This feature is available on our checking and money market account products. If an item (such as a check, ATM withdrawal, ACH transaction, or Visa® Check Card Purchase) is presented against your checking account and exceeds the available funds, we will automatically transfer funds from your Regular Savings Account to cover the overdraft.

Per-Item Fee: A \$5.00 fee will be charged for each transfer that takes place (please refer to the Fee Schedule for more details).

*Customization:* You have the option to redirect these transfers to come from another account or cancel this feature altogether. To make changes, simply contact us.

Liability: By using this service, you agree to hold Fremont Federal Credit Union harmless for any and all liability that may arise if a transfer does not occur.



During this gathering, we'll review our financials for the past year, announce scholarship winners, and conduct our Board elections. Refreshments will be served, making it a delightful occasion to witness the credit union difference firsthand. Having proudly served our members for over 75 years, we look forward to continuing this tradition as we evolve to meet your changing needs. The Nominating Committee will accept additional nominations from any member that may be interested. Those interested must contact Cory Stine, Chair of the Nominating Committee, and schedule an interview to discuss the Duties and Responsibilities of a Board of Director. In addition, each potential Board nominee must submit a letter listing his/her qualifications to be a member of the Board of Directors, along with a petition signed by a minimum of 200 Credit Union Members. This must be completed and to the Nominating Committee by **February 14, 2025**.



A ballot for the Board of Directors election will be provided via the April 2024 Member Newsletter, if warranted, to all eligible voting members 30 days prior to the Annual Meeting. Voting will be closed on **May 8, 2025, at 6:00 p.m.**, five business days prior to the Annual Meeting, and the vote will be tallied. The results will be verified at the Annual Meeting and the Board Chairman will make public the result of the vote at the Annual Meeting.

In the event there is only one nominee for each position to be filled, the election will not be conducted by mail ballot and there will be no nominations from the floor. The Board Chairman may take a voice vote or declare each nominee elected by General Consent or Acclamation at the Annual Meeting.
